

## Who is eligible to apply?

- ✓ Business and commercial property owners with properties in the rural areas of the Regional District.
- ✓ Non-profit societies occupying commercial locations.
- ✓ Home-based businesses (eligible for way finding signage only, up to \$500).

## How does the funding work?

Business/property owners interested in participating can apply for a grant rebate of up to 50% of eligible façade improvement costs, to a maximum of \$5,000 (payable upon demonstration of project completion).

## How do I participate?

1. Review the program guidelines for complete program information and criteria (available online at [www.cariboord.ca](http://www.cariboord.ca) under Community Economic Development or at CRD offices in Williams Lake, Quesnel, 100 Mile House).
2. Complete the application form in the guidelines package and ensure your application includes all requested information.
3. Submit your application to the CRD by email, fax or mail in advance of the application deadline (instructions included in program guidelines).
4. CRD staff will review your application and provide a decision within 2 weeks of receiving the application.

## What is the deadline to apply?

Funding will be committed on a first-come, first-served basis (subject to project eligibility and funding).

## What can I do with this grant?

### Eligible Improvements

- ✓ Exterior Painting
- ✓ Exterior lighting
- ✓ Signage
- ✓ Exterior architectural and decorative details
- ✓ Moldings/trims/false roof peaks
- ✓ Murals
- ✓ Awnings
- ✓ New siding (only front)
- ✓ Accessibility Improvements (if part of larger facade improvement project)

### Eligible Costs

- ✓ Direct project labour
- ✓ Contractor fees
- ✓ Design, architectural or engineering fees
- ✓ Rental of tools and equipment
- ✓ Project related materials & supplies

### Ineligible Improvements

- ✗ Routine maintenance & structural repairs
- ✗ Roofs, patios, landscaping, fencing, paving
- ✗ Non-permanent fixtures (benches, planters, etc.)
- ✗ Interior improvements
- ✗ Improvements not visible from public right-of-way
- ✗ Additions, accessory buildings or new buildings
- ✗ Improvements started prior to application approval

### Ineligible Costs

- ✗ Operational costs, staff wages & benefits
- ✗ Equipment purchases
- ✗ Utilities (hydro, gas, etc.)
- ✗ Duties & shipping costs
- ✗ Permit fees
- ✗ GST/PST

## Why participate?

The appearance of your storefront delivers a vital first impression to the world. An attractive and interesting storefront can generate traffic, especially among tourists. A new look also encourages loyalty as your regular customers see your pride in being part of the community.

If you are a building owner, improving the appearance of your building has many benefits. If you have a future vacancy in your building, exterior improvements can increase the appeal of your location to potential tenants. It shows them you care about your building's appearance and upkeep.

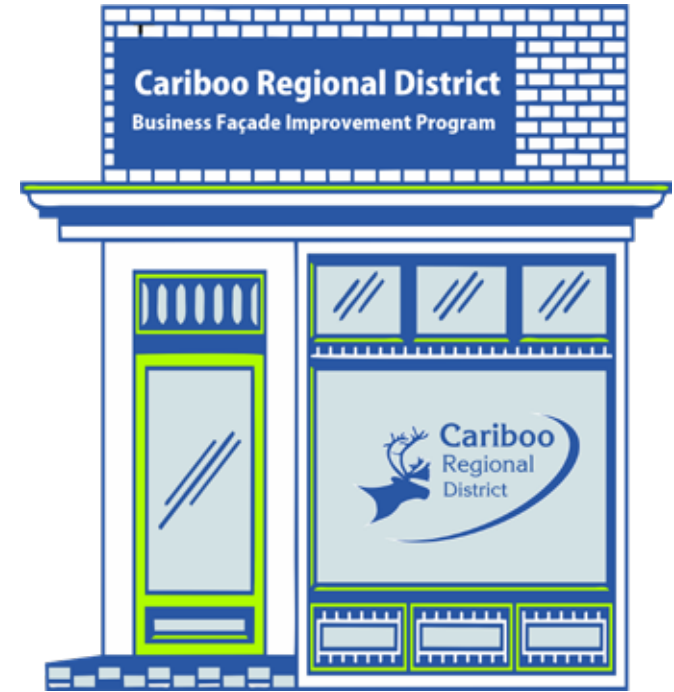
