## SCHEDULE “B” Footnotes and Definitions

### FOOTNOTES

1. **Residential User Fees** apply to residential waste hauled by non-commercial vehicles, unless otherwise permitted by the Region.
2. By appointment only. Load must be accompanied by all required transport and disposal manifests.
3. Loads over 200 or 100 kilograms (as applicable) will be charged for the entire weight of the load.
4. Must be contained in plastic bags, no loose invasive plants will be accepted.

### DEFINITIONS

“**Clean Wood Waste**” means: dimensional lumber such as pallet, construction or demolition wood waste; branches and trees; and wood waste free of wood preservatives, rocks, metals (other than nails, screws and small hinges), heavy coats of paint or glue, wire, fiberglass, asphalt or metal roofing material, plastic coverings or other non-wood material.

“**Contaminated Load**” means:

- **Clean Wood Waste** loads containing greater than 5% combined weight of **Recyclable Waste, Household Waste, or Demolition/Construction Waste**; and/or any amount of concrete/rock, soil/dirt, or metal waste that would damage the wood grinder. Loads containing 50% combined weight of any of the above will be charged DOUBLE the contaminated rate; OR
- **Demolition/Construction Waste** loads containing greater than 10% by weight of **Recyclable Waste, Clean Wood Waste, concrete/asphalt, or scrap metal waste**. Loads containing more than 50% combined weight of any of the above will be charged DOUBLE the contaminated rate; OR
- **Household Waste** loads containing greater than 10% combined weight of **Recyclable Waste, Clean Wood Waste, leaves/grass/sawdust/yard and garden waste, Demolition/Construction Waste, concrete/rock, soil/dirt, or scrap metal waste**. Loads containing more than 50% combined weight of any of the above will be charged DOUBLE the contaminated rate; OR
- Loads of **Controlled Waste** types that contain 10% by weight of other wastes.

“**Secured loads**” means loads which are covered and tied down. Any loads that result in escapement of waste during transport within the site will be charged DOUBLE the applicable fee.

“**Demolition/Construction Waste**” means waste originating from the construction, demolition and/or renovation of buildings and structures including but not limited to: plastics; insulation; roofing; flooring, including carpets; plumbing; electrical; preserved wood or wood containing: rocks, metals (other than nails, screws and small hinges), heavy coats of paint or glue, wire, fiberglass, asphalt roofing material, metal roofing material, and plastic coverings; masonry ceramics; and glass.

“**Household Waste**” means domestic rubbish, waste and discarded materials including but not limited to: food waste; animal waste; plastic products, infant and adult diapers; non-recyclable packaging, crockery and glass, floor sweepings, soiled tissues and paper towels; and fabrics.

“**Non Contaminate Loads**” mean loads containing pre-sorted, uniform waste types.

“**Recyclable Waste**” means ferrous and non-ferrous metals and products included in Extended Producer Responsibility Programs, including but not limited to: deposit beverage containers; solvent and flammable liquids, pesticides, gasoline, pharmaceuticals, lubricating oils, empty oil containers, oil filters, paints, lead-acid batteries, antifreeze, and antifreeze containers; electronic and electrical products, including batteries and accessories; tires; and packaging and printed paper. Recyclables that are soaked, stained, encrusted or otherwise containing: blood, grease, oil, chemicals, excessive food residue, or any type of excrement or other material that will render the Recyclables as unmarketable shall not be included.
