4. DELEGATIONS - Joleen Morrison; Agriculture Education Program Facilitator

Joleen Morrison the newly hired Agriculture Education Program Facilitator was introduced to the committee members and outlined the work that will be taking place to complete the program.

5. NEW AND UNFINISHED BUSINESS

1.1. Cariboo Agricultural Area Plan and proposed ADAC Expansion update:

The CRD Planning Services Department requested ADAC review the following changes to the current ADAC Bylaw in preparation for the proposed ADAC expansion:

- Increase membership maximum from 11 to 13 people.
- Remove the restriction on Advisory Planning Commission (APC) members participating on the ADAC.
- Remove maximum number of terms. Currently members are limited to four consecutive two-year terms.
- The proposal to the Board to increase the committee's annual budget from \$4500 to \$6000, which would be split three ways (\$2000) by each of the economic development functions.

1.3. CNC Community Advisory Committee – Request for an ADAC representative
There is an opening for an agriculture representative to serve on the College of New Caledonia
Advisory Committee. The committee is a broad-based community and regional committee and
has 20-25 representatives, who meet 3 times a year. The collaborative work could be undertaken
as a partnership between ADAC or another agricultural agency or organization and CNC to initiate
training or educational opportunities.

1.4. Strategic Plan Framework

The revisions to the strategic plan will be incorporated and then emailed to all participants of the Strategic Planning Sessions for review and input. The document will also be shared with the new

ADAC members once appointed to help inform them of the broad reach of the goals. In early January once initial review by participants and ADAC members is complete we can invite community members to see if community organization can provide support towards implementation of the tactical plan. In addition, components of the strategic plan framework could inform the work on the formation of the Agricultural Area Plan.

1.5. Reports from ADAC member representative organization

Quesnel Cattlemen's Association report: Reanne Sanford reported the 2020 AGM, delayed due to COVID-19, was held recently. The AGM included director's reports and an overview of programs. Other topics discussed included challenges presented by predators, and conversations on water use and regulation. The BC SPCA inspections on poultry and dairy are a new initiative from the province and they are waiting to hear more about the program.

Martin Rossmann added there was some discussion on roads and the new ditching installed; he noted that it is almost impossible for cattle to cross and if a vehicle went off the road, they would probably end up upside down.

Reanne noted it is also difficult for animals to get to water sources and that some letters have been written, but not sure if they will have any impact.

Lynda mentioned that large strip removal of trees and blow downs have been occurring.

Nicole identified who they could talk to in Ministry of Forests. Reanne said she could be the temporary contact for the Quesnel Cattlemen's Association until a new secretary is assigned.

BC Forage Council: Christa reminded ADAC members of the upcoming Forage Quality workshop being held in Quesnel on November 27th.

Nicole noted a number of workshops and webinars listed in the Roots including the Regenerative Agriculture webinar, the Succession webinar and a Nuts & Bolts follow-up workshop in Williams Lake in February sponsored by Farm Credit Canada. The Ministry is looking to support existing water use applications.

Regional Ministry staff are on an extension pilot with Vanderhoof to get information on insurance and have a 2-page draft document has been prepared for producers to use prior to going in for insurance. It will be reviewed and presented to members of the Small-Scale Meat Producers Association in January. It suggests insurance agencies work with member associations to ensure safe food processing in BC.
