5.2. Election of ADAC Chair, Treasurer and Secretary

Martin Rossmann stepped down as ADAC Chair. There was a call for nominations to the position of Chair for a 1-year term.

Christa Pooley – Chair (Elected by acclamation)

The nominations for Treasurer and Secretary of ADAC will take place at the next ADAC meeting.

5.3. CNC update – Tim Lofstrom

Schools are still figuring out how to move forward with pandemic mitigation. Beginning in May most programs will be online, and at this time there is not a firm announcement of how the fall schedule will look as they are taking direction from Public Health Office.

Pluses and minuses with the process as a whole; Some students are having some difficulties and not experiencing the true college/university experience. Some are taking a pause and considering enrolling in full programs at a later date. On the plus side, there are now many more courses available than before, using an online platform. This is good for some, but others struggle with an online platform. CNC is putting as many supports in place as they can.

On January 20th CNC held an Advisory Committee meeting with a broad representation of community organizations and agencies. ADAC member Erin Durrell is the representative for the Agricultural Development Advisory Committee. They are looking for community organizations or industries to come forward with ideas for partnering on programs. Community programing has a mandate to support employment for students, so programming needs to correlate to labour market participation. They have reached out to the Sprout Kitchen project manager to look at some form of partnership with a food production and culinary focus. They hope to support employment and funding opportunities with small student cohorts.

Government programming is coming forward with funding opportunities, which are being reviewed. The current programming will finish in May and new programming will begin in August.

5.4. CRD Committee of the Whole meeting update

The ADAC members attending the Committee of the Whole meeting commented that the presentations and discussion at the meeting were very positive and provided a better understanding of the agriculture industry. The members noted that improved coordination and planning between industry, government and residents will assist with issues related to the urban/rural interface, pressures on land planning and development, and provide the opportunity

to make changes and recommendations which will strengthen the Official Community Plan. It was noted that the ADAC has provided valuable insights during their term of service.

The Committee of the Whole meeting ended with direction to the CRD staff to develop a discussion paper on options and alternatives to supporting an Agriculture Area Plan, which is to be brought forward to the next Committee of the Whole meeting on March 4th.

5.5. ADAC Strategic Planning session

It was noted the guest presenters have been confirmed and the participant list, strategic planning session outline and power point were reviewed and suggestions will be incorporated.

Suggested topics for next Strategic Planning session scheduled for March 12 were discussed and it was suggested we include non-timber agriculture products as a topic. Land based decisions are being made on what are now forested lands, but opportunities could be available for an expansion of the land usage.

Nicole suggested an ADAC member could be included in the Community Forest working group to provide input and advice on agri-forestry issues. Nicole noted the City of Quesnel and local First Nations have been offered a Community Forest tenure. In a press release of the initial meeting held on June 24, 2020, it was noted "the various interested governments will collaborate on forming a working group to define the collective governance structure, scope out the community engagement process, define key priorities, and work with Ministry staff on determining the location of the community forest".

Christa Pooley: In the last 2-weeks Christa has been taking part in a CHAT workshop, a communication tool for the agriculture industry to participate in "difficult conversations" i.e. animal welfare. She said it was a very useful and simple tool, which can also be used with social media.

Lynda Atkinson: BC Agriculture Council hosts these workshops at no cost and Lynda could help support the process if an organization wanted to provide the workshop.

Christa Pooley: Is also planning to be involved in a program assisting with Cow-Calf cost of production analysis.

Lynda Atkinson: Nationally the Canadian Federation of Agriculture is looking at the broad sweep of supports for agriculture. There may be some changes to the programs i.e. loan programs, with some of the funding being forgivable. The concern is that COVID will be an issue for most of 2021 and foreign labour is an issue owing to the Federal government changing travel regulations.

4. DELEGATIONS

Darlene Clark: Regional Manager, Cariboo Regional Economic Operations Branch - Rural Opportunities, Tenures and Engineering Division; Ministry of FLNRORD

The Cariboo Regional Economic Operations Branch existed to support job development and training, especially in the tourism industry. The branch moved to the Ministry of Forests, Land, Natural Resource Operations & Rural Development in 2017 to support the work of the Ministry of Forests, agriculture and other land-based resources. The Ministry works with Indigenous and rural communities to strengthen and diversify their economies. The branch is working with societies, municipalities, and other local governments to act as a catalyst to the work they are implementing. They help by providing linkages and garner support by making connections. Previously, Darlene worked in jobs supporting economic development in particular with forestry, as well as permitting with natural resources and land planning.

Martin noted the Ministry of Forests, Land, Natural Resource Operations & Rural Development will be downsized and separated into divisions. Darlene noted the Ministry is growing with the addition of a Parliamentary Secretary to assist the Minister in meeting the commitments outlined in the mandate. Darlene noted it is helpful to receive information and updates from ADAC.

John asked who the parliamentary secretary is for this Ministry? Darlene noted the new Minister of FLNRORD is Katrine Conroy and the Minister of State for Lands and Natural Resource Operations is Nathan Collin. The Parliamentary Secretary for Rural Development is Roly Russell. Darlene noted she will also be working closely with Ravi Kahlon, the Minister of Jobs, Economic Recovery and Innovation.

Darlene noted she will be working within the region of BC spanning from Clinton to Prince George until November of 2021, when Emily Colombo returns to the Ministry.
