Agricultural Area Plans

An Agricultural Area Plan focuses on a community's farm area to discover practical solutions to issues and identify opportunities to strengthen farming and ultimately to contribute to agriculture and the community's long-term sustainability. These plans are often referred to as an Agricultural Area Plan or Agricultural Area Strategy.

B.C.'s Local Government Act makes provision for municipalities and regional districts to develop official plans for portions of their jurisdictions - often referred to as neighbourhood or local area plans. The Agricultural Land Commission (ALC) and Ministry of Agriculture actively support local government initiatives to develop Agricultural Area Plans.

Components

While every agricultural planning area is unique with a specific set of challenges and opportunities, there are a number of common features to the process of developing an Agricultural Area Plan. These include:

- The planning process is led by the municipality or regional district
- Care is taken in defining the agricultural planning area
- An agricultural planning steering committee normally guides the process
- The steering committee should be inclusive of members of the farm community an Agricultural Advisory Committee may be called upon to assist or act as the Agricultural Area Plan steering committee
- Ministry and Agricultural Land Commission representatives are often asked to participate and provide resource assistance
- The information base is strengthened by such means as land use inventories, statistical material and the development of a background report
- Issues and opportunities are identified to guide the emerging plan policies
- The plan's policies are intentionally "action oriented" providing practical solutions to the local issues that are identified
- A clear plan for implementation is included
- Organizations that are best positioned to implement solutions are identified

Assistance

For local governments that may be interesting in developing an agricultural area plan, ministry and Agricultural Land Commission staff provide advice based on their experience working on similar projects with other municipalities and regional districts.

Informational material has also been developed by the ministry related to agricultural area plans and land use inventories and GIS to assist with local planning efforts. The ministry may also be able to assist the process with the development of agricultural statistical products.

RURAL DIVIDEND PROJECT DEVELOPMENT GRANT NORTH CARIBOO AGRICULTURAL DEVELOPMENT ADVISORY COMMITTEE PROJECT UPDATE

The purpose of this Project Development application is to hire a facilitator to assist the newly formed North Cariboo Agricultural Development Advisory Committee (ADAC) move forward their recommendations and strategic agriculture plan; and to work towards establishment of a Quesnel Agriculture Centre through further consultation and assessment of the possible partners and funders to a new centre.

DELIVERABLES AS OUTLINED IN AGREEMENT:

OUTCOME RESULTS

Hiring of an Agricultural Development Advisory Committee Facilitator:

Sonoran Resources Management Ltd. was hired to facilitate project on June 1, 2018.

Hired facilitator will consult with the agricultural industry and organizations to build the Quesnel Agricultural Centre member base and gather information for the Strategic Agriculture Plan:

The Facilitator and Project Coordination Team worked with the City of Quesnel Economic Development Officer to assist Greenchain Consulting, the team hired to develop a business plan for the Regional Agri-food Centre using funding provided to the City of Quesnel by the Ministry of Agriculture. The assistance provided by the team include:

• The organization of 3 workshop sessions for Potential Partners to the Quesnel Agriculture

- Centre including Government agencies (City, CRD, Province) Local/regional agencies and associations and Organizations with food enterprise support services;
- The organization of 2 workshop sessions for primary producers and processors, and organizing visits with potential purchasers including facility tours;
- The organization of an Open House to present the draft Regional Agri-food Centre Business Plan and continuation of final consultations;
- Providing the consulting team with transportation and other hospitality requirements;
- Recording minutes of the Quesnel Agriculture Centre Business Plan Steering Committee meetings and workshop sessions;

Completion of a communication strategy for the Quesnel Agriculture Centre:

The Facilitator and Project Coordination Team worked with the City of Quesnel Economic Development Officer to develop group email and phone lists of Government agencies, Local and regional agencies and associations and Organizations with food enterprise support services.

Completed communication strategy is implemented.

These lists were distributed to Greenchain Consulting to conduct interviews for additional consultation and input and used by the team to communicate the invitations to potential partners and stakeholders of the Quesnel Agriculture Centre Workshop sessions.

Completion of a Strategic Agricultural Plan for the Quesnel Agriculture Centre. Completed plan will include public input and community consultation gathered via an information session.

The draft business plan of the Quesnel Regional Agri-food Centre was presented at the Open House held on December 10, 2018 at the Quesnel Royal Canadian Legion. The facilitator, Project Coordination Team and City of Quesnel Economic Development Officer organized the event, including the promotion, hosting and registration of participants. The business plan concept was presented on large boards allowing the public to walk through, circulate and ask questions or provide input. The consulting team presented on overview of the information once the majority of participants were assembled.

Promotional activities for the event included a colour advertisement in the local newspaper, promotion though various local agencies and social media, large poster advertisements at local kiosks throughout the city and email distribution. Rural Dividend Project Development funds were used to host and promote the workshops and Open House.

Greenchain Consulting used the information gathered at the Open House to continue consultations and completion of the business plan, which is currently being reviewed by the Ministry of Agriculture.

ADDITIONAL OUTCOMES OF THE RURAL DIVIDEND PROJECT

The Agricultural Development Advisory Committee of the North Cariboo prioritized strategic plan recommendations are located on page 5 of this document. The Facilitator and Project Coordination Team worked to move forward these recommendations by completing the following activities:

Agriculture Education Program:

A grant application to the Rural Dividend Project Development fund was submitted on July 30, 2018 and approved on January 17, 2019. Partnerships for the Agriculture Education Program implementation were formed during this process and include:

- School District 28 Quesnel
- Kersley Farmers Institute
- Ministry of Agriculture
- BC Forage Council
- Richbar Nursery
- College of New Caledonia

The Project Coordination Team contacted the Agriculture in the Classroom (AITC) Executive Director, Patricia Tonn and arranged for AITC Education Specialist, Amy Stafford to travel to Quesnel to present 2 information sessions on Agriculture in the Classroom to Elementary and Secondary Teachers at the Non-instructional Day held on January 28, 2019. The sessions were well attended, with representation by a majority of schools in the district and many members of the Agricultural Development Advisory Committee. In addition to the AITC presentation, local 4H representatives presented information on their program and its many benefits. A presentation on the Agricultural Development Advisory Committee was also provided. Funding for the AITC Education Specialist travel was provided by the Rural Dividend Project Development grant.

BC Forage Council Field Day:

The BC Forage Council held a provincial Field Day event on August 25th, 2018, at the Roddie Creek Ranch just west of Quesnel. The facilitator worked with the BC Forage Council organizing committee to assist in the set-up, event activities and clean up of the event in support of forage research and knowledge extension. The event was well attended with over 80 people registered.

Agricultural Development Advisory Committee:

The facilitator and Project Coordination Team worked with the ADAC committee on various administrative duties of the newly established committee. These administrative duties include:

- Meeting preparation including distributing the agenda, communicating with committee members, recording and distributing minutes of the ADAC meetings;
- Setting up an email address for ADAC northcaribooadac@gmail.com;
- Setting up the ADAC webpage on the Cariboo Regional District website including meeting dates on the CRD events calendar. The agendas and approved minutes are posted on this webpage – www.cariboord.ca/agriculture;
- Development and printing of an Agricultural Development Advisory Committee brochure.

Once the work on the Regional Agri-food Centre business plan was completed, Sonoran Resource Management gave notice they could no longer work on the project and the work with this facilitator team was finalized.

In February 2019 a contractor was hired to complete work for the Agricultural Development Advisory Committee webpage on the Cariboo Regional District website. The work includes the reformatting of the minutes of the ADAC committee meetings from June through November 2018, formatting photos for the ADAC webpage and compiling the work completed by ADAC for the 2018 year.

Another contractor is in the process of being hired to do some research on a First Nations Communications Strategy for ADAC. The components of this project include to:

- Identify the Tribal Councils and First Nations in the North Cariboo region;
- Research information on these Tribal Councils and nations including governance structure, history, and if possible, identifying any interests in food or agri-food production;
- Provide web links to all researched information; and
- Develop and record the best strategies to communicate with the Tribal Councils and First Nation groups.

It is estimated the work of both contractors noted above will be completed by the last week in March and the final reporting for this grant will be completed. An income statement for the Rural Dividend Project Development grant funding as of February 15, 2019 is included below.
