5. OLD AND UNFINISHED BUSINESS

5.1. Agricultural Area Plan (AAP) – Shivani

5.1.1 Members were encouraged to review the agricultural Area Plan (AAP) document and provide input on actionable priorities for the next year.

Key Topics that were discussed:

- (a) Education on Farming
 - (i) Proposal to increase agricultural education in schools, educate the public on farming realities and train officials on agricultural related matters.
- (b) Invasive plants
 - (i) Issues of spreading noxious plants were discussed with a suggestion to invite Alex Mutch from the invasive species council of BC for guidance.
 - (ii) Recommendations to align invasive species management with soil and grazing practices.
- (c) Meat Processing
 - (i) members emphasized the importance of Class A abattoirs and expanding cut and wrap facilities.
 - (ii) Highlighted the closures of abattoirs and its impact on small scale meat producers.
 - (iii) Noted gap in processing for poultry, sheep and goats.
 - (iv) Suggestions to explore mobile or smaller scale facilities for local needs.

 - (i) Challenges noted around biosecurity and insurance concerns.
 - (ii) Suggestions to collaborate with TRU's agritourism courses and tourism associations to address these barriers.
