Hello and good evening,

Yesterday I was at the South Cariboo Cattlemen's Association AGM and there was discussion about the challenge of new residents not familiar with the Livestock Act, specifically that livestock are allowed to be at large (except pigs), in most cases. If someone does not want cattle on their property, they need to fence them out. I suggested this might be a good topic for the Agriculture Area Plan to consider for discussion.

- 1. While BCCA has created a video for Realtors regarding the fencing in agriculture areas, it is felt the legislation is not fully disclosed prior to a sale
- 2. Lack of fencing in subdivisions has led to harassment of livestock, and poor relations among neighbours
 - a. Recall the Edge Planning topic at the recent Ministry AAC Workshop, and the challenge with subdividing larger parcels
- 3. South Green Lake Rate Payers Association (TNRD) paid to have a fence built, the rancher maintains it
- 4. Cattleguards and lack of maintenance by the road owner (MOTI/Dawson, Resource Roads, non-status roads) is leading to livestock at large, and added costs for ranchers
