Attention: Cariboo Regional District Bylaw Board of Directors

This letter is to bring to your attention an issue that is happening in the Anderson Subdivision in 100 Mile House. Owners of a vacant lot on Mulligan Drive are planning to move a couple of RV's on their vacant lot, along with an outhouse. Unfortunately, in 2014 a property owner did move an RV onto his lot on Mulligan Drive, which they use as his home when they are here. Wolf Rd. has many RV's set up on lots and has become very unsightly. Also structures are being built over these RVs. We feel because this is a subdivision and not an RV site, none of this should be allowed. You would not allow this breach of the bylaw to happen in town, and although our subdivision is ten minutes from town, we should not be treated any different. We understand that aesthetics are subjective, but you cannot ignore the health and sanitation of this issue. How is the sewage of these RVs being disposed of? Again, we are a subdivision.

My husband and I personally have owned our home for over 20 years, following the rules, applying for permits for improvements, and paying large amounts in taxes to coincide with those improvements. In the last few years some property owners have not respected such bylaws, thinking because they are non residents, and only here part time, they can basically do as they wish, and in the process bring down the value of the full time residential homes in the area. I understand the CRD bylaw board, at a meeting, has decided not to enforce its own bylaw in this matter. We would like to know why, since "Bylaws should be governed by impartial law, not the changing whims of men or women." This decision was wrong and unfair to the majority of permanent residents. Since we do live in a democratic society, the residents should have a say on what affects us.

As I understand, "bylaws were created as a way to address issues and concerns of the local community. They were created to protect the environment, public and private property, and to ensure public health and to maintain an orderly appearance in the community and city. A bylaw may regulate or define the rights and responsibilities of citizens by prohibiting or otherwise controlling certain activities."

We are requesting you follow the guidelines of the bylaws, and deny any permits for RVs being moved in as a part time or full time place of residence in the Anderson subdivision.

Although we (Larry and Vickey Ramey) have written our concerns and wishes, we are attaching a list of signatures of Anderson Subdivision property/home owners that are also concerned with these same issues. We are formally requesting the CRD board members vote to enforce the bylaws they put in place.
